

I-9 Instructions

1. Print Last, First Name and Middle Initial if any; Address, Apt Number (if any), City, State and Zip Code; Date of Birth and SSN. E-mail Address and Telephone Number are optional.
2. Choose the box indicating you are authorized to work.
3. Now pay close attention please. An employer cannot specify which documents are to support your I-9. You may use documents shown in List A or one document in List B AND one document in List C.

Please note the following:

- a. If you have an "A Number" you can use the document with your "A Number" shown on it for Page 1.
- b. If you use an I-94 you must also include your current Passport Number and the country issuing the Passport for Page 1.
- c. You can also use a Driver's License AND a Social Security Number to support your I-9 (I will put this information on Page 2).

After making your choice you must then provide me with a notarized copy of the original documents along with Page 1 only of your I-9. I will do the rest.

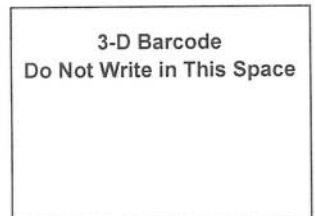
